Our journalist Aristidis Aggelopoulos took a short interview from the distinguished lawyer and ICJ Coordinator, Mr. Robert Stern.

After having participated in MUNs around the world and coordinated the ICJ what makes the difference between this committee and the others?

The ICJ is unique. It is a court! it's not a General Assembly, it's neither a committee not a commission. It has its own rules and rather unique procedures related to the legal system. It has different terminology. You don't use points of order. It's a court room and as realistic as possible. It's not exactly the same as the International Court of Justice because they usually don't have witnesses. It makes it more interesting for the students as it requires certain skills. The participation is constant and they have to be attentive the entire time they are involved. There are open speeches. They bring evidence to the advocate. There are questions to advocates and questions to witnesses. When they're all finished, the judges face all the evidence and present it. It includes stipulation and also real evidence. Then the judges discuss it, argue it and see which side persuaded them. It's a completely different set of policies and procedures.

Has your attitude towards life changed throughout your experience as a Public Defender?

I think I was always sensitive to the people who were disadvantaged. My whole life, my professional career has been spent trying to help the disadvantaged and I certainly saw that side of life from the part of the defender. I "translated" that into teaching and helping students. Not that students are necessary disadvantaged, but they have needs and I like to be involved and help people who have certain needs in order for them to be creative, able to better themselves and be better than they are. Now, at that particular time that I'm retired, I still do the ICJ program and teach, and get to work with kids. I also do some volunteer legal work in England giving free legal advice to the poor and the disadvantaged. So, I have my hands even in retirement both in the law and teaching and I get the best out of these two

worlds.

Do you believe in Justice?

Oh! Absolutely! What is interesting, what is nice for me is to be able to see the jury! People who sit in juries are smart people; they understand and they see through all the testimonies. Normally the reach appropriate decisions almost all the time. That is not perfect. Nothing is a perfect system. There are mistakes. You read about these mistakes in the newspaper. You think they happen all the time, but if you think that there are thousands and thousands of cases happening ... most of them do the right.

How was your experience in the Atsmun conference?

Fa-nta-stic! It was very good, I enjoyed it. I liked it very much. We were a little concerned because the students started late the IC. They started the research late but they have done a wonderful job and especially most of the kids, I have been working with, are nice creators. They picked up all the legal concept, exploited the issue, took the steps and debated really really well! The decision taken is appropriate and they can justify it. They have done a great job and I have been taken a wonderful care of you and everybody has been kind. Patras is a lovely city and the hospitality is first rate. It has been terrific! I would be very happy to return and do it again and I think so does everybody who has been involved.

Keeping up with the committees...

International Court of Justice

The day started with a witness testimony and the ICJ Members admitted the evidence. Objections took place, some of which were sustained by the President. The Advocates proceeded with closing arguments. Later on, nine issues were noted on the flip chart, which were discussed after an initial vote. Mr. Stern coordinated the overall trial.

Historical Committee

During the session of the Historical Committee, the Italian scientist Gabrielle Petrakis was murdered and we have organized a research to reveal the perpetrator. Also, the Ottoman empire was threatened to be expelled from the Entente Coalition. She was brought before justice to answer to the accusations she endured.

Advisory Panel

The second day of the ATSMUN started with a sudden crisis in the committee. Chaos was caused when, during the debate, FBI agency ran into the committee and announced the death of Kim Jongun in US soil. The delegates worked under pressure to reach an agreement but they concluded to the declaration of WW3. After intense and flaming debate, they rejected the idea of war and reached a diplomatic agreement.

European Council

In the EU Council there has been conducted a fruitful debate on very important issues of our days, such as the combat of terrorism in Europe and the direction that Europe needs to follow in order to maintain its protagonist role in wold's events.

Special Political and Decolonization Committee

We discussed two resolutions on the issue of Nagorno Karabakh, one from Azerbaijan and the other from Russian Federation. Some amendments were made, one of which passed. In general, the delegates were quite active and their speeches were to the point. All in all, the debate was constructive and even heated sometimes.

UN Council on fighting ISIS

Security Council
